PIT PAVILION SUITES

Located directly above the garages there is no better place to get up close and personal with the teams. All spaces are air-conditioned with an open-air balcony facing directly onto pit straight with large Super screens in view.

Options starting at: 30 guests up to 300 guests



PIT EXIT SUITES



Located at pit exit with sweeping views looking back down pit straight and toward the chicane, these spaces also have a rear balcony allowing you some track viewing of turns 12 and 13. All spaces are air-conditioned with a front facing balcony and Super screens in view.

Options starting at: 30 guests up to 200 guests

CHICANE DRIVER'S RIGHT

See the cars come racing right at you out of pit straight and charge through the chicane as you sit trackside right next to the fence. Spaces are open air with a split-level balcony and private entry stairs via the rear of the facility.

Options starting at: 25 guests up to 200 guests



CHICANE DRIVER'S LEFT

Enjoy sweeping views across the entire chicane as the cars accelerate out into turn 3 with large SuperScreen in full view. All spaces are air-conditioned with an outdoor two-tier deck and private entry stairs from the rear or side.

Options starting at: 30 guests up to 200 guests

CHICANE CLUB

Located within the Chicane Drivers Right area, enjoy the luxury of a reserved space within a shared space. Tables of 10 are put together over the split level with small table of 4 on the bottom level and high table for 6 at the top. Amazing views and an all-inclusive food and beverage package.

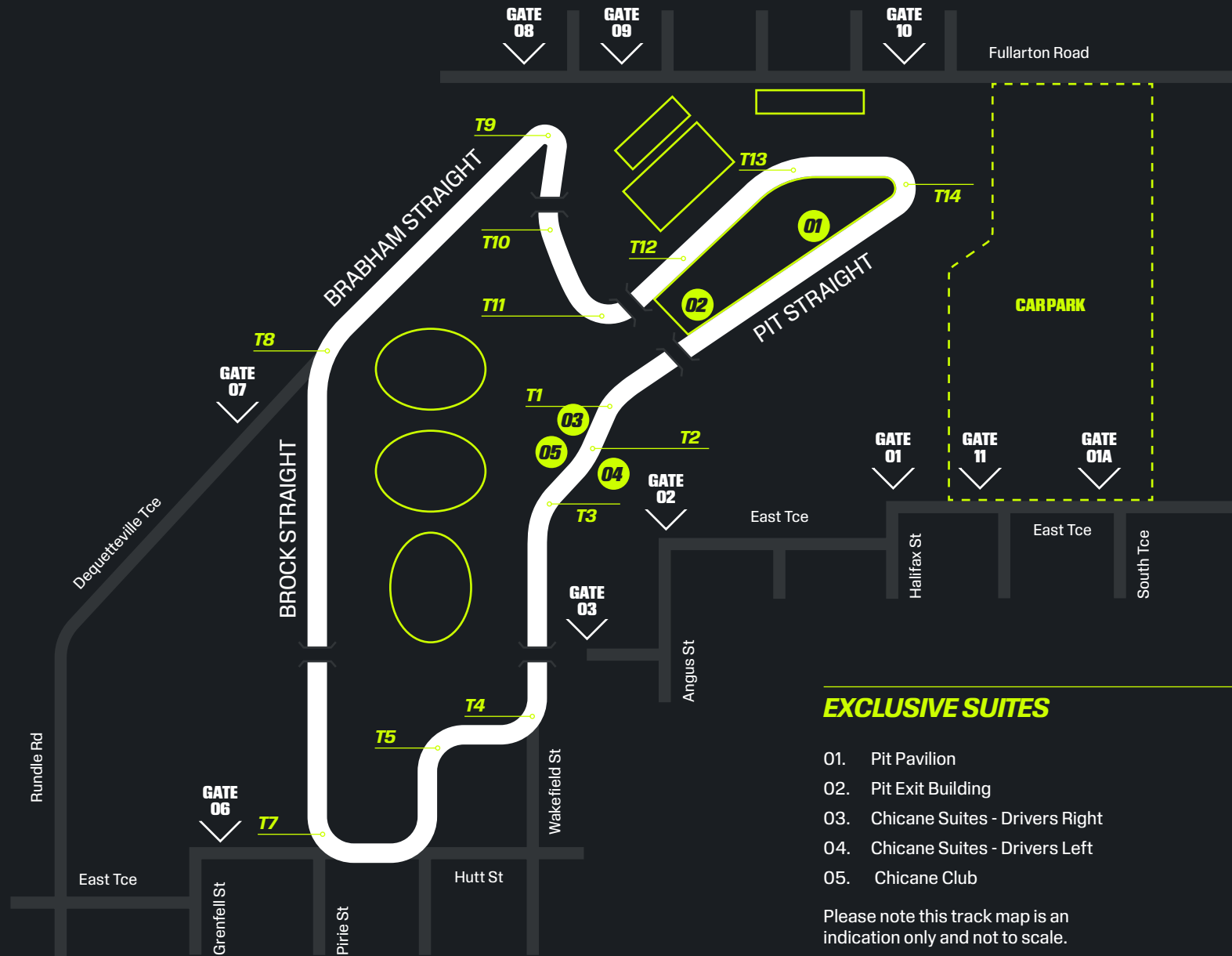

IMPORTANT INFO 2026

FOOD & BEVERAGE

All food and drinks are ordered directly through our official event catering company, GEMA Group, and are additional costs for each day. All prices include GST and are subject to change. They can cater for any dietaries or special requests given enough notice.

TICKETING

Tickets are sent electronically to the person nominated on the booking form no later than 14 days before the event and once full payment is received. Wristbands are collected from the Hospitality Concierge daily by the suite holder for distribution by the suite host on the day to all guests.

SUITE FIT OUT

All exclusive suites are fitted with contemporary furniture, large drink fridges, service tables and TV screens. Furniture upgrades can be arranged prior to the event. Our team can also assist with theming and fit out of your suite, however prior approval must be sought prior to any signage installation or activation. No external suite signage is currently permitted.

SUPERCARS PADDOCK PASSES

Exclusive suite holders, and your guests all have access to the Supercars Paddock, located at the rear of the Pit Building, at no extra charge.

DEPOSIT

A non -refundable deposit of 10% of the purchase price of your suite must be paid within 5 working days of your booking being confirmed and invoiced. However, if your booking is made after the date which is 60 days prior to the event, full payment will be required at the time of booking and all amounts will be non refundable.

CHILD POLICY

Infants and children under the age of 18 are permitted to enter your suite at your discretion. However, they must be accompanied by an adult at all times and hold a valid entry ticket for the suite.

CANCELLATION POLICY

Bookings may only be cancelled in writing via email to hospitality@adelaidegrandfinal.com.au. Please see terms and conditions hereafter for full details.

TERMS AND CONDITIONS

BOOKING CONDITIONS

- Bookings for a Corporate Facility (as defined in The bp Adelaide Grand Final Booking Form) (a "Booking") must be made by completing and submitting the booking to the South Australian Motor Sport Board, a body corporate pursuant to the *South Australian Motor Sport Act 1984 (SA)* ABN 43 976 679 496 ("SAMSB").
- By submitting a Booking to SAMSB, you warrant that you are authorised to make the Booking on behalf of the party set out in the booking form and agree to the Terms and Conditions of Booking as stated herein.
- Bookings will be confirmed and considered binding once The bp Adelaide Grand Final Booking Form is completed and submitted, which will be determined by SAMSB at its complete discretion.

DEPOSIT

- A non-refundable deposit of 10% of the purchase price for all Exclusive Suite Bookings (the "Deposit") must be paid within five (5) business days of SAMSB confirming such a Booking. SAMSB will provide a receipt when the Deposit is received. Notwithstanding, tickets in respect of any Bookings for any Corporate Hospitality will only be issued upon full payment of the relevant purchase price to SAMSB (subject to ticket availability and at the discretion of SAMSB) per Clause 6 below.
- Payments may be made by instalments or in full, as nominated. Shared Suite Bookings must be paid directly via the online booking page using a valid credit card. Larger Shared Suite Bookings may request an invoice for payment (provided at the discretion of the Booking Manager). Payments not

made within the agreed invoice payment period will be deemed void and booking cancelled.

- Full payment of the purchase price for the Booking must be made to SAMSB **no later than 60 days prior** to The bp Adelaide Grand Final (the "Event"). If full payment is not received at this time SAMSB may, at its complete discretion, cancel the Booking and retain the Deposit already paid (nb. deposit only required for Exclusive Suite Bookings). For the avoidance of doubt, Bookings made **after** the date which is **60 days prior** to the Event will require payment in full **at the time of the Booking**.
- If payments are made by direct bank transfer, an invoice number or the full name as set out on the Booking must be quoted in the bank transfer reference. Failure to do so may result in you not receiving credit for the payment.

CANCELLATION POLICY

- Bookings may only be cancelled in writing to SAMSB via email to hospitality@adelaidegrandfinal.com.au. A cancellation is not deemed to have been received unless acknowledged by return email.
- If an Exclusive Suite Booking is cancelled **on or before** the date which is **60 days prior** to the Event, SAMSB will retain the Deposit paid.
- If any Corporate Hospitality Booking is cancelled **after** the date which is **60 days prior** to the Event, SAMSB will retain the full amount of the Booking. You will not be eligible for any refund after this time

TICKETS

- Tickets cannot be used for promotional purposes or on sold by or to a third party without the prior written consent of SAMSB.

12. Tickets cannot be used by more than one person per day.

13. Tickets for all Corporate Facilities will be sent electronically to the person nominated on the booking form. As stated in Clause 4, tickets will not be sent until full payment of the purchase price for the Booking has been received by SAMSB.

14. Entry to a Corporate Facility is subject to the Event's entry terms and conditions as set out in the Conditions Imposed on Tickets | bp Adelaide Grand Final and displayed at the entry gates to the relevant Event precinct. Entry may be refused to guests not holding or displaying appropriate credentials.

15. Ticket holders are required to conduct themselves in a manner acceptable to SAMSB at all times. SAMSB reserves the right to refuse entry or to remove any ticket holder that behaves in an unacceptable manner, including (without limitation) any manner that threatens any person (including SAMSB staff), being intoxicated or not complying with our policies including, but not limited to, meeting dress standards, no smoking, no external food and beverage, COVID-19 distancing and restrictions as per Legislation in the State of South Australia.

16. Ticket holders must not, without the prior written consent of SAMSB,; (a) use any trade mark or other intellectual property owned by SAMSB; or (b) conduct any advertising or promotion in relation to the Corporate Facility or the Event, including, without limitation, any corporate signage or corporate identification within or outside the Corporate Facility; or (c) use the name of SAMSB or of the Event in any way that connects it with you

such that it implies or gives the impression that you or your activities are endorsed by SAMSB or that you are a sponsor or in some other way connected to SAMSB or the Event.

INDEMNITY

- To the maximum extent permitted by law, SAMSB and its related body corporate (including officers, employees and agents) shall not be liable for any loss, damage, expenses or injury (including but not limited to indirect, special, incidental, exemplary or consequential loss) arising out of or in connection with a ticket holder's attendance at the Event.
- SAMSB will not be liable for any loss or damage to any item of property brought into a Corporate Facility by a ticket holder. Ticket holders are to ensure that they keep all valuable items in their possession at all times, including (but not limited to) all SAMSB gifts, merchandise, wallets, cameras and mobile phones. SAMSB will not accept responsibility for the loss or, or damage to, any personal items.
- In addition, by making a Booking you acknowledge and agree to the Event's Entry Terms and Conditions as set out here: Conditions Imposed on Tickets | bp Adelaide Grand Final

CHILDREN

- Infants and children under the age of 18 are permitted to enter an Exclusive Corporate Facility at the discretion of the Booking Manager. All infants and children under the age of 18 are required to be accompanied by an adult at all times and must hold a valid entry ticket to the Exclusive Corporate Facility.

TERMS AND CONDITIONS

21. Infants and children under the age of 14 are not permitted to enter Shared Suites. Minors aged 14 years and over must be ticketed and have accreditation in line with the accompanying adult.
22. Infants and children under the age of 18 are not permitted to enter areas designated by SAMSB as "Lounges" or "Platinum Suites".

PRIVACY

23. By making a Booking, you acknowledge and agree that SAMSB collects and may use and/or disclose any personal information provided in relation to the Booking (including, without limitation, regarding all ticket holders) in accordance with the SAMSB Privacy Policy | bp Adelaide Grand Final. SAMSB may disclose this Booking and/or information in relation to this Booking in either printed or electronic form and either generally to the public or to a particular person as a result of a specific request. Nothing in this clause derogates from: (a) your obligations under any provisions of this Booking; or (b) the provisions of the *Freedom of Information Act 1991 (SA)*.

CATERING

24. Catering must be purchased from the SAMSB event appointed caterer and this will be invoiced directly by the caterer. For the avoidance of doubt, Corporate Facilities cannot be occupied without catering and viewing only is not permitted. Responsible service of alcohol shall be operated by SAMSB and the Event. All bar opening and closing times may be subject to change by SAMSB in its absolute discretion.

UNFORESEEN EVENTS

25. SAMSB is excused from performing its obligations under this Booking to the extent it is prevented by circumstances beyond its reasonable control, including but not limited to acts of God, natural disasters, acts of war, weather, government imposed health restrictions, riots and strikes outside its organisation.

TERMINATION BY SAMSB

26. SAMSB may immediately terminate this Booking by notice in writing if: (a) Payment is not made for the Booking in accordance with these Conditions; (b) there is a breach of any other term of this Booking and: (i) the breach cannot be remedied; or (ii) you fail to remedy such breach within 7 days of receipt of a written notice from SAMSB requiring you to do so, (c) you assign or purport to assign any of your rights or obligations under these Conditions in breach of this Booking; or (d) you enter into or are placed under any form of insolvency administration, are insolvent, or otherwise unable pay your debts as and when they fall due.

EFFECT OF TERMINATION BY SAMSB

27. Unless otherwise agreed in writing by SAMSB, you agree that immediately upon termination by SAMSB under these Conditions: (a) you will forfeit all monies paid to SAMSB prior to termination; (b) SAMSB will be free to enter into an agreement with any third party covering any or all of the rights, benefits and entitlements contained within the Booking; and (c) the forfeit of any monies pursuant these Conditions and the termination of the Booking will not preclude any other rights which

SAMSB may have against you as a result of their default including, in particular, the right to claim damages for breach of the Agreement or otherwise at law.

GOVERNING LAW

28. This Booking will be governed by and construed in accordance with the laws of South Australia, and the parties submit to the exclusive jurisdiction of the courts of that State.

DEFINED TERMS

29. *Booking Manager* means the person responsible for the Booking
30. *Corporate Facility* means the hospitality facility selected by the SAMSB in response to the Booking and as defined in The bp Adelaide Grand Final Booking Form
31. *Exclusive Suite Bookings* means you have exclusive use of the Corporate Facility during the Event
32. *Shared Suite Bookings* means you are limited to joint or shared use of the Corporate Facility during the Event.
