SHARED PACKAGES

TICKETING PACKAGE

Tickets will be sent electronically to the person nominated on the booking form no later than 14 days before the event and will not be sent until full payment of the purchase price for the booking has been received. Wristbands will be provided to all guests upon arrival at the suite.

SUITE HOSTS

All shared suites have in-house hosts to assist with guest arrival, provision of wristbands and can assist with daily programs.

DRESS CODE

Corporate casual - dress jeans, dress shorts and racing shirts are acceptable. Guests wearing tank tops, singlets, sports/activewear and/or thongs will be refused entry to the suite.

CHILDREN POLICY

Infants and children under the age of 14 are not permitted to enter shared hospitality suites. Minors aged 14 years and over must have a ticket and have accreditation in line with the accompanying adult. Infants and children under the age of 18 are not permitted to enter The Pit Lounge, Platinum suite or Sofia Bistro.

NO SMOKING POLICY

All suites, villas, walkways, and garages are designated non-smoking areas. Please see the official track map for the designated smoking areas.

CASHLESS

No cash facilities are available in the shared suites. Bar tabs and other purchases are available using credit/debit cards only.

ACCESSIBILITY

We have a number of wheelchair and accessibility friendly facilities as set out on page 3. Please reach out to one of our team who will help you select a suitable facility for you and your guests.

CANCELLATION POLICY

Purchased tickets in shared hospitality are non-refundable unless the event is cancelled by the SA Motor Sport Board. In that case, the ticket price is refunded in full within 30 days of the announcement.

TERMS AND CONDITIONS

BOOKING CONDITIONS

1. Bookings for a Corporate Facility (as defined in The bp Adelaide Grand Final Booking Form) (a "Booking") must be made by completing and submitting the booking to the South Australian Motor Sport Board, a body corporate pursuant to the *South Australian Motor Sport Act 1984 (SA)* ABN 43 976 679 496 ("SAMSB").
2. By submitting a Booking to SAMSB, you warrant that you are authorised to make the Booking on behalf of the party set out in the booking form and agree to the Terms and Conditions of Booking as stated herein.
3. Bookings will be confirmed and considered binding once The bp Adelaide Grand Final Booking Form is completed and submitted, which will be determined by SAMSB at its complete discretion.

DEPOSIT

4. Payments may be made by instalments or in full, as nominated. Shared Suite Bookings must be paid directly via the online booking page using a valid credit card. Larger Shared Suite Bookings may request an invoice for payment (provided at the discretion of the Booking Manager). Payments not made within the agreed invoice payment period will be deemed void and booking cancelled.
5. Payments may be made by instalments or in full, as nominated. Shared Suite Bookings must be paid directly via the online booking page using a valid credit card. Larger Shared Suite Bookings may request an invoice for payment (provided at the discretion of the Booking Manager). Payments not made within the agreed invoice payment period will be deemed void and booking cancelled.

6. If payments are made by direct bank transfer, an invoice number or the full name as set out on the Booking must be quoted in the bank transfer reference. Failure to do so may result in you not receiving credit for the payment.

CANCELLATION

7. Bookings may only be cancelled in writing to SAMSB via email to hospitality@adelaidegrandfinal.com.au
8. If an Exclusive Suite Booking is cancelled on or before the date which is 60 days prior to the Event, SAMSB will retain the deposit paid.
9. If any Shared/Exclusive Hospitality Booking is cancelled after the date which is 60 days prior to the Event, SAMSB will retain the full amount of the Booking. You will not be eligible for any refund after this time.

TICKETS

10. Tickets cannot be used for promotional purposes or on sold by or to a third party without the prior written consent of SAMSB.
11. Tickets cannot be used by more than one person per day.
12. Tickets for all Shared/Exclusive facilities will be sent electronically to the person nominated on the booking form. As stated in Clause 4, tickets will not be sent until full payment of the purchase price for the Booking has been received by SAMSB.
13. Entry to a Corporate Facility is subject to the Event's entry terms and conditions as set out in the Conditions Imposed on Tickets | bp Adelaide Grand Final and displayed at the entry gates to the relevant Event precinct. Entry may be refused to guests not holding or displaying appropriate credentials.
14. Ticket holders are required to conduct themselves in a manner acceptable to SAMSB at all times. SAMSB reserves the right to refuse entry or to remove any ticket holder that behaves in an unacceptable manner, including (without limitation) any manner that threatens any person (including SAMSB staff), being intoxicated or not complying with our policies including, but not limited to, meeting dress standards, no smoking, no external food and beverage, COVID-19 distancing and restrictions as per Legislation in the State of South Australia.

15. Ticket holders must not, without the prior written consent of SAMSB, (a) use any trade mark or other intellectual property owned by SAMSB; or (b) conduct any advertising or promotion in relation to the Corporate Facility or the Event, including, without limitation, any corporate signage or corporate identification within or outside the Corporate Facility; or (c) use the name of SAMSB or of the Event in any way that connects it with you such that it implies or gives the impression that you or your activities are endorsed by SAMSB or that you are a sponsor or in some other way connected to SAMSB or the Event.

INDEMNITY

16. To the maximum extent permitted by law, SAMSB and its related body corporate (including officers, employees and agents) shall not be liable for any loss, damage, expenses or injury (including but not limited to indirect, special, incidental, exemplary or consequential loss) arising out of or in connection with a ticket holder's attendance at the Event.
17. SAMSB will not be liable for any loss or damage to any item of property brought into a Corporate Facility by a ticket holder. Ticket holders are to ensure that they keep all valuable items in their possession at all times, including (but not limited to) all SAMSB gifts, merchandise, wallets, cameras and mobile phones. SAMSB will not accept responsibility for the loss or, or damage to, any personal items.
18. In addition, by making a Booking you acknowledge and agree to the Event's Entry Terms and Conditions as set out here: Conditions Imposed on Tickets | bp Adelaide Grand Final.

TERMS AND CONDITIONS

CHILDREN

19. Infants and children under the age of 18 are permitted to enter an Exclusive Corporate Facility at the discretion of the Booking Manager. All infants and children under the age of 18 are required to be accompanied by an adult at all times and must hold a valid entry ticket to the Exclusive Corporate Facility.
20. Infants and children under the age of 14 are not permitted to enter Shared Suites. Minors aged 14 years and over must be ticketed and have accreditation in line with the accompanying adult.
21. Infants and children under the age of 18 are not permitted to enter areas designated by SAMSB as "Lounges" or "Platinum Suites".

PRIVACY

22. By making a Booking, you acknowledge and agree that SAMSB collects and may use and/or disclose any personal information provided in relation to the Booking (including, without limitation, regarding all ticket holders) in accordance with the SAMSB Privacy Policy | bp Adelaide Grand Final. SAMSB may disclose this Booking and/or information in relation to this Booking in either printed or electronic form and either generally to the public or to a particular person as a result of a specific request. Nothing in this clause derogates from: (a) your obligations under any provisions of this Booking; or (b) the provisions of the *Freedom of Information Act 1991 (SA)*.

CATERING

23. Catering must be purchased from the SAMSB event appointed caterer and this will be invoiced

directly by the caterer. For the avoidance of doubt, Corporate Facilities cannot be occupied without catering and viewing only is not permitted.

Responsible service of alcohol shall be operated by SAMSB and the Event. All bar opening and closing times may be subject to change by SAMSB in its absolute discretion.

UNFORESEEN EVENTS

24. SAMSB is excused from performing its obligations under this Booking to the extent it is prevented by circumstances beyond its reasonable control, including but not limited to acts of God, natural disasters, acts of war, weather, government imposed health restrictions, riots and strikes outside its organisation.

TERMINATION BY SAMSB

25. SAMSB may immediately terminate this Booking by notice in writing if: (a) Payment is not made for the Booking in accordance with these Conditions; (b) there is a breach of any other term of this Booking and: (i) the breach cannot be remedied; or (ii) you fail to remedy such breach within 7 days of receipt of a written notice from SAMSB requiring you to do so, (c) you assign or purport to assign any of your rights or obligations under these Conditions in breach of this Booking; or (d) you enter into or are placed under any form of insolvency administration, are insolvent, or otherwise unable pay your debts as and when they fall due.

EFFECT OF TERMINATION BY SAMSB

26. Unless otherwise agreed in writing by SAMSB, you agree that immediately upon termination by SAMSB under these Conditions: (a) you will forfeit all monies

paid to SAMSB prior to termination; (b) SAMSB will be free to enter into an agreement with any third party covering any or all of the rights, benefits and entitlements contained within the Booking; and (c) the forfeit of any monies pursuant these Conditions and the termination of the Booking will not preclude any other rights which SAMSB may have against you as a result of their default including, in particular, the right to claim damages for breach of the Agreement or otherwise at law.

GOVERNING LAW

27. This Booking will be governed by and construed in accordance with the laws of South Australia, and the parties submit to the exclusive jurisdiction of the courts of that State.

DEFINED TERMS

28. *Booking Manager* means the person responsible for the Booking
29. *Corporate Facility* means the hospitality facility selected by the SAMSB in response to the Booking and as defined in The bp Adelaide Grand Final Booking Form
30. *Exclusive Suite Bookings* means you have exclusive use of the Corporate Facility during the Event
31. *Shared Suite Bookings* means you are limited to joint or shared use of the Corporate Facility during the Event.
